1 . Main points

- Producer input prices rose by 4.9% in the year to July 2026, down from a revised rise of 7.4% in the year to June.
- Producer output (factory gate) prices rose by 3.1% in the year to July 2026, down from a rise of 3.5% in the year to June.
- On a monthly basis, producer input prices fell by 1.7% and producer output (factory gate) prices rose by 0.2% in July 2026.
- Crude oil provided the largest contribution to the fall in the annual inflation rate for input prices in July 2026, with prices falling by 18.0% on the month.
- Refined petroleum products provided the largest contribution to the fall in the annual inflation rate for output prices in July 2026, with prices falling by 2.9% on the month.

2 . Inflation figures

Producer input prices rose by 4.9% in the year to July 2026, which is down from a revised increase of 7.4% in the year to June (Figure 1). Monthly input prices fell by 1.7% in July 2026, up from a revised fall of 1.9% in June (Table 1).

Producer output (factory gate) prices rose by 3.1% in the year to July 2026, which is down from an increase of 3.5% in the year to June (Figure 1). Monthly output prices rose by 0.2% July 2026, up from a revised fall of 0.1% in June (Table 1).

The largest contribution to the annual input producer price inflation rate was an upward contribution from inputs of metals and non-metallic mineral products, where prices rose by 8.4% over the past year. The largest contribution to the change in the annual input producer price inflation rate was a downwards contribution from crude oil, where prices fell by 18.0% between June and July. The largest contribution to the annual output producer price inflation rate was an upward contribution from outputs of coke and refined petroleum products, where prices rose by 30.1% over the past year. Coke and refined petroleum products also provided the largest downward contribution to the change in the annual output producer price inflation rate, with prices falling by 2.9% between June and July. 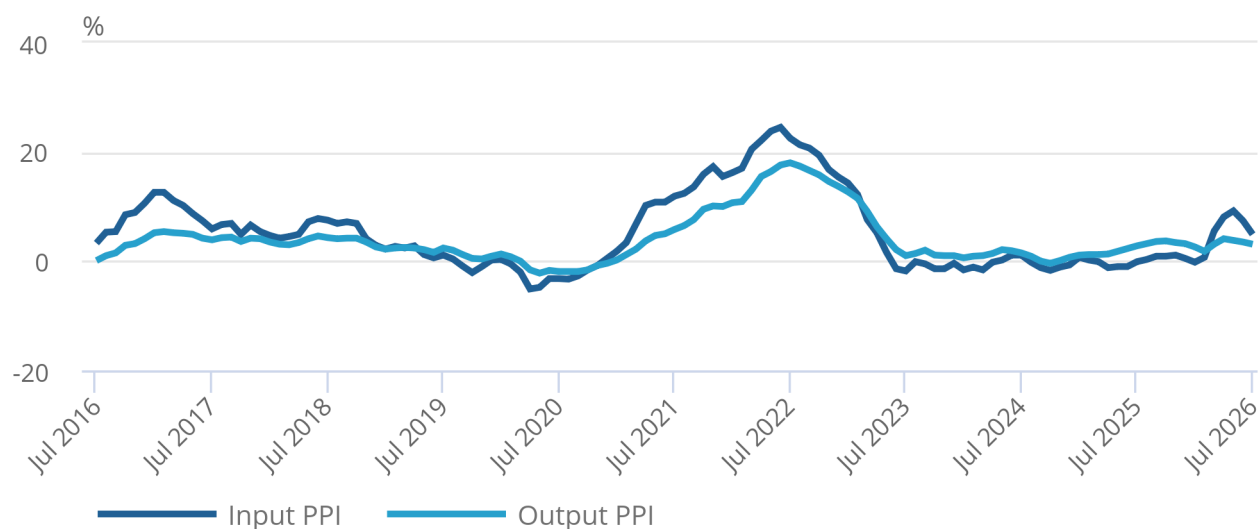

Producer Price Index (PPI) estimates for both June and July 2026 are provisional. PPI figures for the latest 12 months are subject to revisions as additional survey data are returned and validated. 3 . Input prices

Of the 10 product groups for the input Producer Price Index (PPI), 9 made upward contributions to the annual inflation rate in July 2026. The largest of these came from inputs of:

- metals and non-metallic mineral products
- chemicals

The prices of inputs of metals and non-metallic mineral products rose by 8.4% in the year to July 2026, compared with a revised increase of 9.0% in the year to June (Table 2). The annual price rise in July was partly caused by increases in prices of basic iron, steel and ferro-alloys, and by non-EU imports of precious metals, in particular silver.

The prices of chemicals rose by 6.1% in the year to July 2026, compared with a revised increase of 6.7% in the year to June (Table 2). The annual price rise in July was partly caused by plastic products, which saw large price rises attributed to the effect of the conflict in the Middle East.

The only offsetting downward contribution to the annual inflation rate came from inputs of domestic food, where prices fell by 1.6% in the year to July 2026, down from a revised fall of 1.3% in June (Table 2). The annual price fall was partly caused by price falls in milk from dairy cattle. On a monthly basis, domestic food input prices fell by 0.5%, while imported food prices fell by 0.1%.

Crude oil provided the largest contribution to the downwards change in the annual inflation rate between June and July 2026. The prices of inputs of crude oil rose by 10.6% in the year to July 2026, compared with a revised increase of 41.9% in the year to June (Table 2). On a monthly basis, crude oil prices fell by 18.0% in July 2026, up from a revised decrease of 20.9% in June.

Fuel covers electricity and gas (D35) and coal (B05), according to [Eurostat's Classification of products by activity \(CPA 2.1\)](#).

The Import Price Index (IPI) measures the price of materials and fuels imported by UK manufacturers. It rose by 5.2% in the year to July 2026, down from a revised increase of 9.0% in the year to June. On a monthly basis, import prices fell by 2.5% between June and July 2026, compared with a revised fall of 1.6% between May and June. The annual price rise was mainly caused by non-EU imports of refined petroleum products. The sterling effective exchange rate rose by 0.6% in the year to July 2026, up from a fall of 1.4% in the year to June (Table 3).

4 . Output prices

Of the 10 product groups for the output Producer Price Index (PPI), 8 made upward contributions to the annual inflation rate in July 2026. The largest of these came from:

- outputs of coke and refined petroleum products
- other outputs from manufacturing
- basic metals, fabricated metal products and machinery

Prices for coke and refined petroleum products rose by 30.1% in the year to July 2026, down from a revised rise of 41.3% in the year to June (Table 4). Petroleum products also provided the largest contribution to the downwards change in the annual inflation rate between June and July 2026. On a monthly basis, prices for this product group fell by 2.9% in July 2026, up from a revised decrease of 7.0% in June.

Prices for other outputs from manufacturing rose by 4.6% in the year to July 2026, up from a revised rise of 4.5% in the year to June (Table 4). This reflected higher prices for plastic products, with input costs of PVC and resin increasing because of the conflict in the Middle East. Repair services of fabricated metal products, machinery and equipment also had higher prices.

Prices for basic metals, fabricated metal products and machinery rose by 5.0% in the year to July 2026, down from a revised rise of 5.2% in the year to June (Table 4). Higher prices for machining services were a main cause.

There were offsetting downwards contributions to the annual rate from:

- outputs of motor vehicles and other transport equipment
- outputs of food products

Prices for motor vehicles and other transport equipment fell by 1.6% in the year to July 2026, up from a revised decrease of 1.8% in June (Table 4).

Prices for food products fell by 0.8% in the year to July 2026, down from a revised fall of 0.6% in the year to June (Table 4). This was partly caused by falls in the prices of dairy and cheese products.

The Export Price Index (EPI) rose by 8.5% in the year to July 2026, down from a revised rise of 10.5% in the year to June. The annual price rise was partly caused by exports of precious metals. On a monthly basis, export prices fell by 0.9% in July 2026, down from a revised rise of 0.9% in June.

6 . Glossary

Contribution

As the aggregate producer prices indices are built up from individual product indices, it is possible to decompose overall inflation into contributions from different products. Those contributions reflect both the inflation rates for each product and their weight in the index.

Input prices

The price of materials and fuels bought by UK manufacturers for processing. It includes materials and fuels that are either imported or sourced from within the domestic market. It is not limited to materials used in the final product but includes what is required by businesses in their normal day-to-day running, such as fuels.

Output prices

The amount received by UK producers for the goods that they sell to the domestic market, also known as factory gate prices. It includes the margin that businesses make on goods, in addition to costs, such as labour, raw materials and energy, as well as interest on loans, site or building maintenance, or rent.

Producer price inflation

The change in the prices of goods bought and sold by UK manufacturers, including price indices of materials and fuels purchased (input prices) and factory gate prices (output prices). If the producer price inflation rate is a positive value, this indicates that prices have risen, while a negative value indicates that prices have fallen.

Services producer price inflation

The quarterly estimates monitoring the changes in prices charged for services provided to UK-based customers for a range of industries.

Weight

The importance of the price of interest relative to other prices collected. With annual chain-linking, this is updated every year, using business sales revenue data.

Development of producer price statistics

We are continuing to improve the quality of these statistics to address the findings and requirements set out in the Office for Statistics Regulation's (OSR's) [Spotlight on Quality: PPI publication](#). Information on how we plan to address the OSR requirements can be found in our [Producer prices development plan: October 2025 article](#). Once the developments are complete, we will begin the process for seeking reaccreditation. These statistics are currently designated as official statistics.

Oil and energy data

The crude oil data are collected from the four crude oil refining businesses within the UK. It is based on the volume and value of oil purchases made in the first part of the month (typically the first week), supplemented with the refining businesses' estimate of the volume and value of purchases for the remainder of the month. It should be noted that these purchases will represent a (varying) mix of future and spot prices.

The oil derivatives data (diesel, gas oil and aviation turbine fuel) are also collected from the refining businesses. The process is like that used for crude oil but refers to sales, rather than purchases.

The unleaded petrol data are sourced from pump prices from a range of business types. They are based on weekly data with the necessary tax elements removed.

The gas and electricity data are an average price for the month from a panel of suppliers relating to the supply of gas and electricity to industrial and commercial end-users. These data differ from the data provided for the purposes of the Consumer Prices Index (CPI). The data include a mixture of fixed price contracts and flexible price contracts, compiled by the Department for Energy Security and Net Zero (DESNZ). Like the oil data, the first estimate is based on the average price for the first part of the month (based on the volume and value of the energy supplied), supplemented with the suppliers' estimate of the volume and value for the remainder of the month.

All these figures are revised as new data (for example, on the volumes and values of oil purchased) and are received after one to two months.

Response rates

In July 2026, the response rates for the domestic PPI, the Import Price Index (IPI) and the Export Price Index (EPI) were all higher than they were in July 2025 (Table 5).
